- Renewal of Registration of Society if any, be ensured.
- The Government may specify additional conditions from time to time, for compliance.
- "Capitation fee" means any kind of donation or contribution or payment other than the fee notified by the 17. 18.
- school. Child" means a male or female child of the age of six to fourteen years.
- 'Child belonging to disadvantaged group" means a child belonging to the Scheduled Caste, the Scheduled 19 Tribe, or Other Backward Classes, who belongs to a family that is below the poverty line or is a disabled child as per the provisions contained in Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation)

- Though the recognition to the Privately Managed School has been granted for five years, yet the concerned institution has to seek renewal on yearly basis before commencement of next academic session.
